If your application is accepted, you must pay an additional non-refundable fee per record. No more than 2 broken leases/evictions will be accepted. Proof of Identity. State or Government identification is required to rent an apartment. For example: State issued Driver License, State issued Identification Card, Green Card, Foreign ID Card, or Passport. Proof of Income. You must prove your gross monthly income is 2.5x (times) the amount of the rental rate. We
